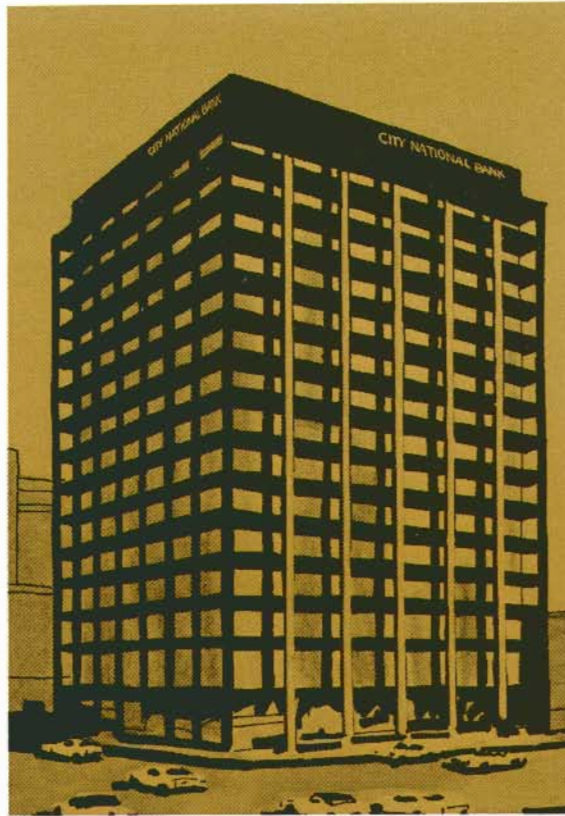
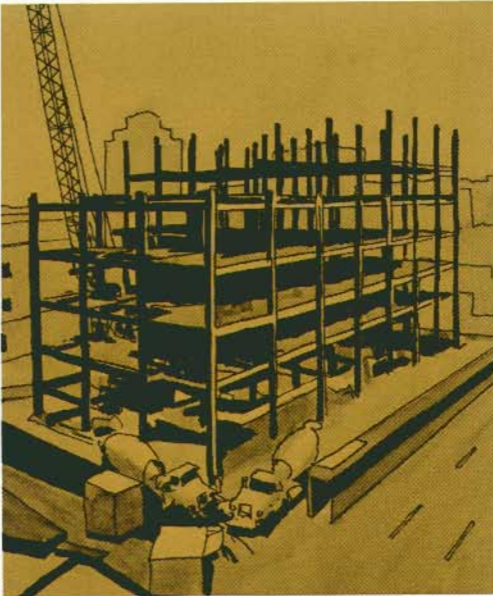

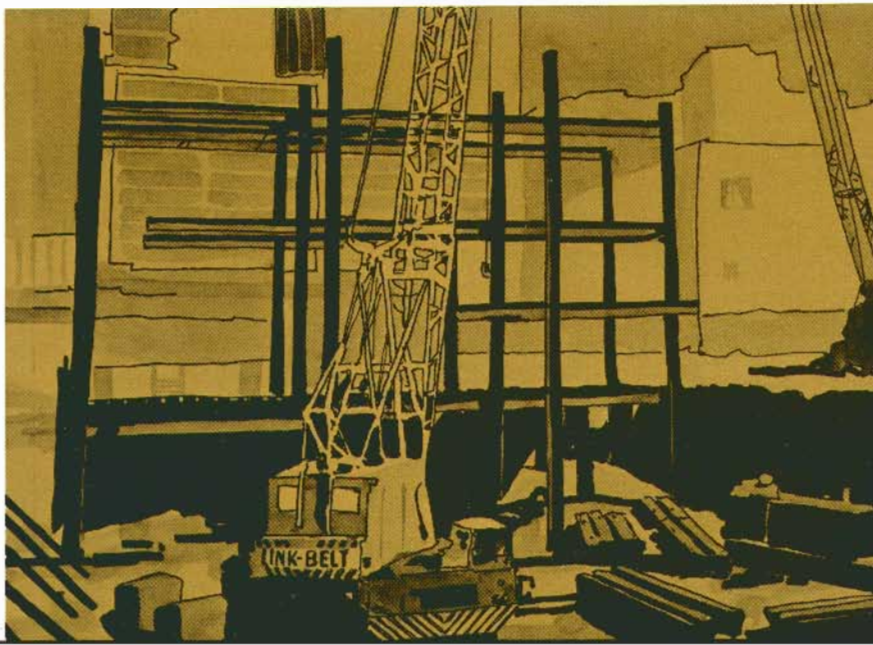


By April, 1970, the building was beginning to take shape—a shape that would have all Austin talking by 1971.



A startling different look comes to the Austin skyline with the advent of the new City National Bank Building. Unlike any other downtown building, the new bank will set the standard for Austin construction for years to come.

Eleven floors of the 15-story building will be devoted to tenancy by progressive Austin business firms who want to be associated with the "future look" that characterizes the new structure.

So . . . the building. And what a building!



Plaza Level

The lovely lower level of the new building employs a pastoral motif. Called the "Plaza Level," it utilizes space beneath the sidewalk all the way to the curb line of both Congress Avenue and Ninth Street. In order to give this area the same benefits of light and air as upper floors, sunken courtyards rife with flora surround the building's base. Conference rooms and other spaces face these courtyards through glass walls, giving an "inside-outside" aspect to the entire

area. Meetings being conducted here can never be afflicted with that "closed-in" feeling that can stifle creative thinking.

The main vault is also located on the Plaza Level, and is among the largest in this part of Texas. It contains 4,700 square feet and is surrounded by one and one-half foot thick reinforced concrete.

Altogether, the unique "Plaza Level" will be among the building's most delightful areas.

The second floor of our new facility houses both business and pleasure quarters. Our ever-expanding Trust Department, headed by John A. Wolf, Senior Vice President, is located on this floor. The Trust Department offices face a lovely paved and landscaped courtyard. Another officer of the bank is officed here, Ronald C. Schultz, Vice President, who heads up our Trust Investment Counseling Department.

The second floor is also home to our Real Estate Department, run by W. C. ("Dub") Brown, Senior Vice President.

This department is most active in interim financing for several of Austin's leading home builders and general contractors.

Both executive and employee dining rooms are found on the second floor. These spacious dining facilities will serve handsomely the culinary needs of bank employees and officers, as well as function as meeting rooms when necessary.

Rounding out the second floor are credit offices and check printing facilities for the City National Bank depositors.

Street Level

As it will be the focal point of the building and the portion with which the public will be most in contact, the main lobby was designed to be unique in this part of the United States.

Conceived as one large space covering most of the first floor, its spaciousness is further reinforced with 17-foot ceilings. Spatial continuity is achieved through use of brick paving covering the whole ground level from curb to curb, including sidewalks.

In the middle of the lobby is located a circular Tellers' island 46 feet in diameter. Customers can be served by as many as 22 Tellers. A staff elevator within the circle drops to the Vault one floor below, giving Tellers efficient and secure access. The elevator shaft enclosure is topped by a spectacular 17-foot circular planter, which is illuminated by a skylight.

Floor area at the perim-

eter of the main lobby serves as the Officers' Platform, and spatial definition will be achieved solely through distinctive furnishings and colorful area rugs, without partitions.

Walk-up Teller windows are also available at street level. Unprecedented in Austin banking, these "kiosks" are arranged on the Ninth Street side of the bank. They are cylindrical booths set under the overhanging second floor, but separated from the building. Location is convenient both from streetside and from the City National Parking Building across Ninth Street.

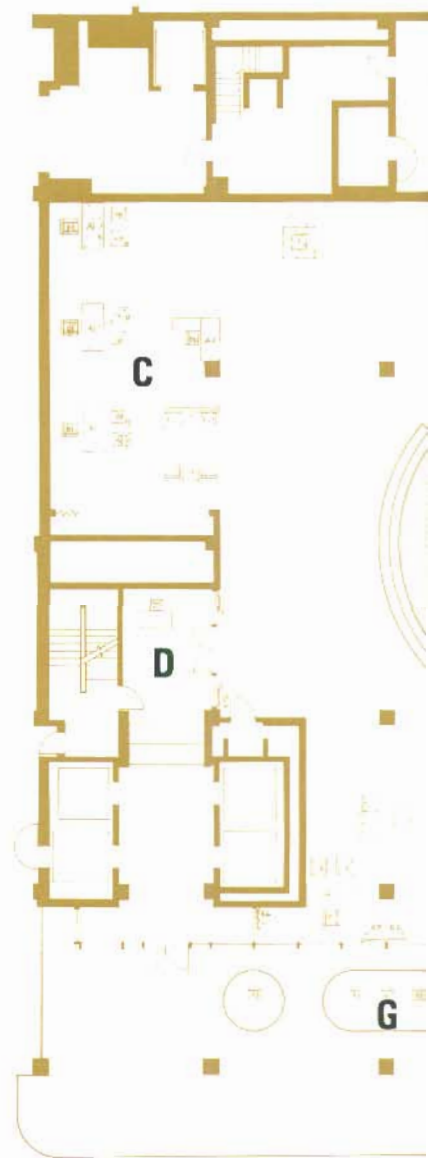
All floors are served by four elevators grouped at the rear of the building, with the elevator lobby entrance on Ninth Street. Operating at 700 feet per minute—a little over 1 second from floor to floor—the elevators are Austin's fastest.

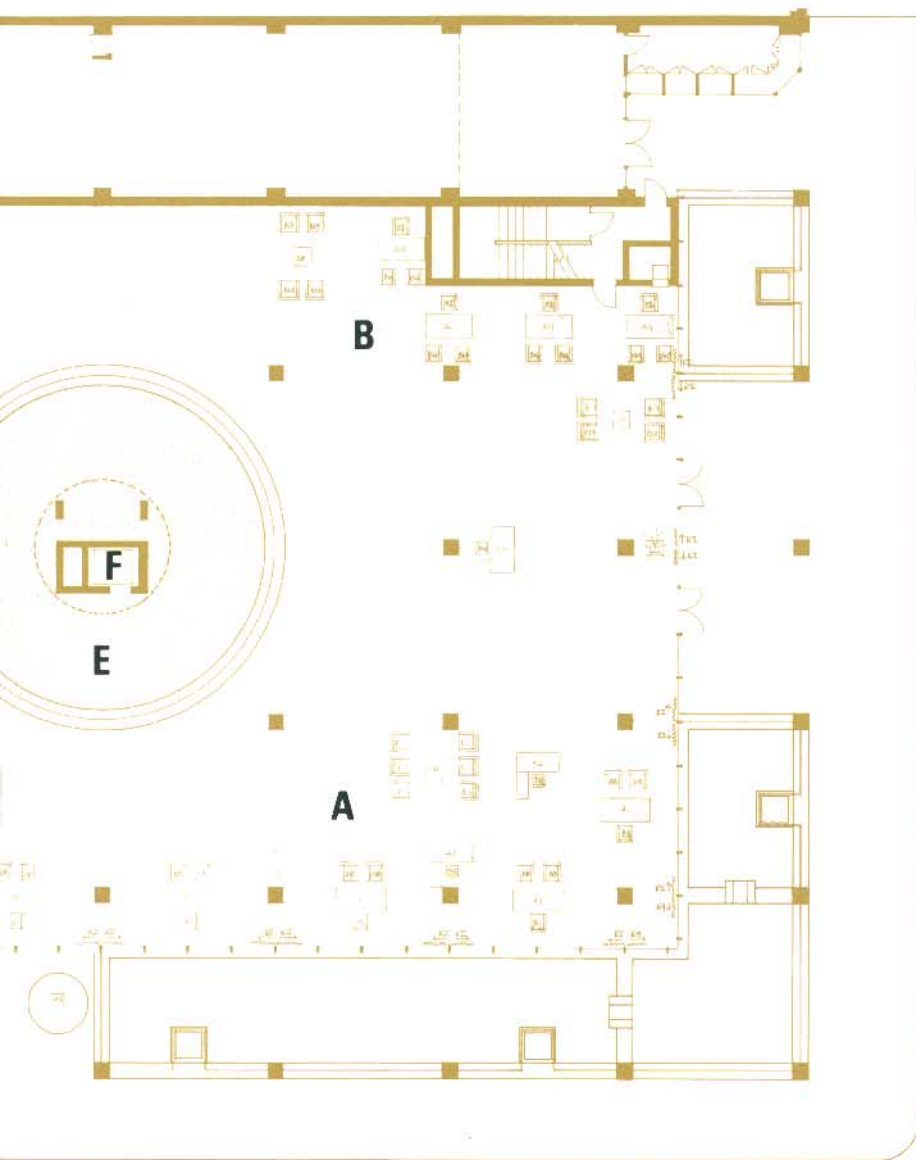
Our busy Correspond-

The third floor also houses our burgeoning Data Processing Department, under the guidance of Jim Reeves. In 6 years, City National has moved into a fully

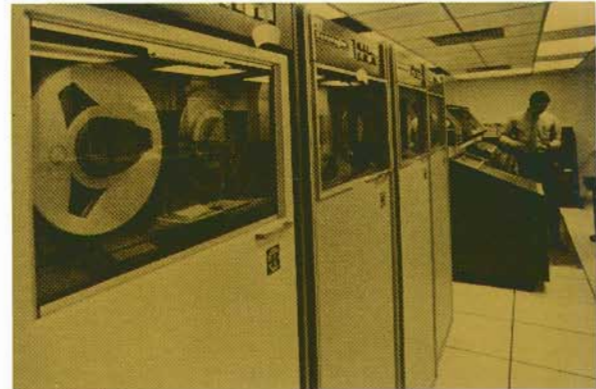
automated environment, serving not only its needs but also many other financial and commercial institutions in the Central Texas area.

The fourth floor is devoted primarily to our Master Charge and Installment Loan Departments.

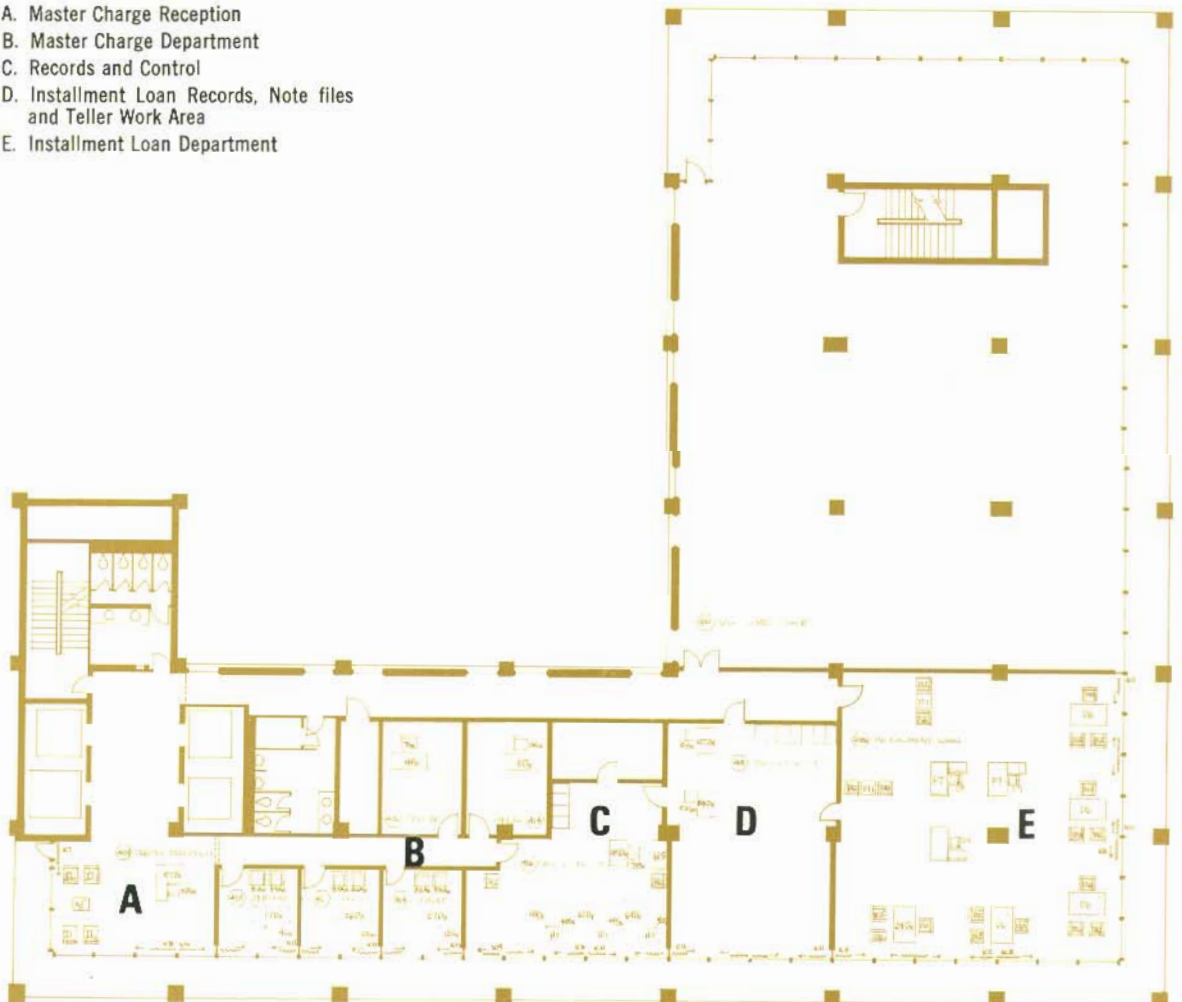
In November, 1968, we introduced the now popular Master Charge credit system as a means of increasing the bank's share of customer credit business. Since that time, the program has grown impressively under the direction of Richard Logan, and today is one of the

bedrock services offered by our bank.

Our Installment Loan Department is totally self contained on this floor. All files, notes and records are maintained and processed daily by its own officers and tellers.

The remainder of the fourth floor is used as work rooms, reception areas, and other offices for various bank services.

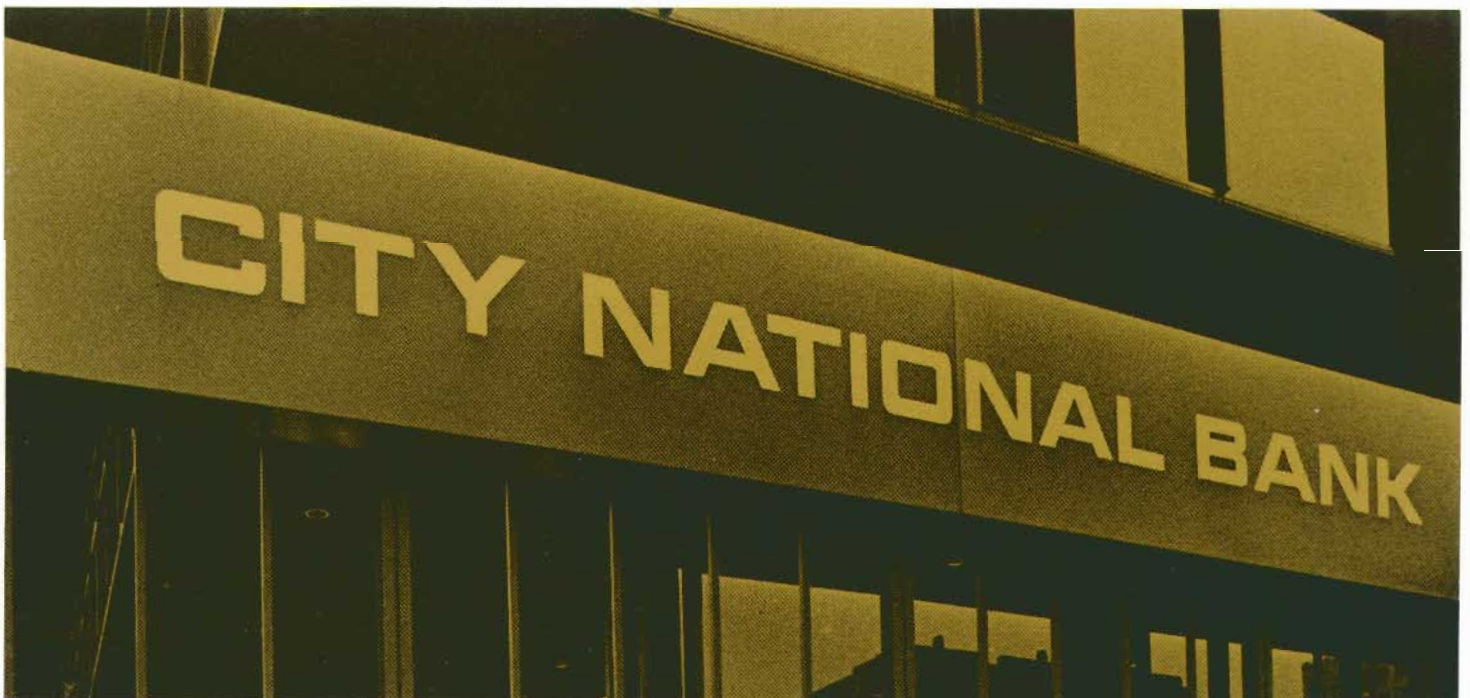

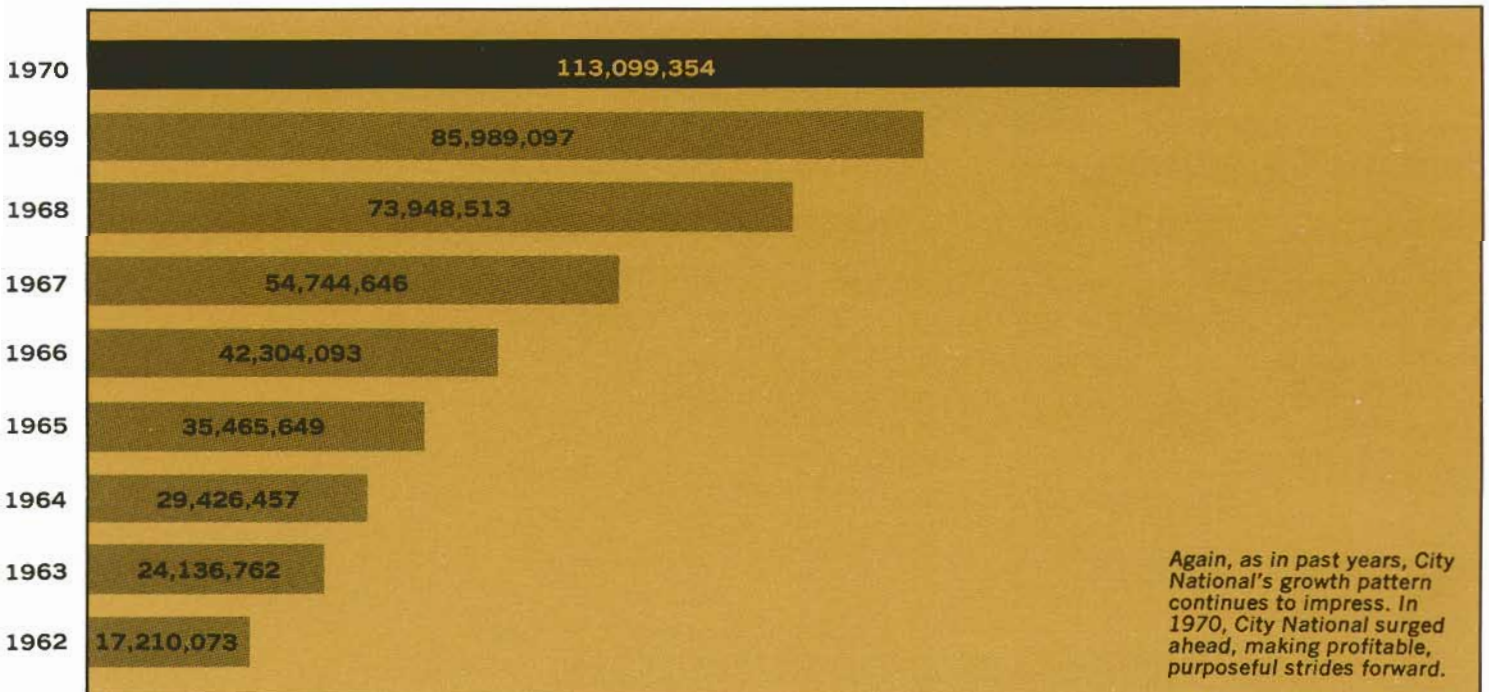
